ISSUE OF SECURITIES - CLEANSING NOTICE

Belararox Limited (“**BRX**” or “**the Company**”) advises that on 31 October 2024, it has issued 22,400,000 fully paid ordinary shares (**Shares**) pursuant to a placement.

The Shares were issued to sophisticated and exempt investors at \$0.25 per Share. The Shares will rank equally with the existing Shares of the Company.

Cleansing Notice

The Company issued the Shares on 31 October 2024 without disclosure to investors under Part 6D.2 of the *Corporations Act 2001* (Cth) (**Act**).

 - (i) has been excluded from a continuous disclosure notice given to ASX in accordance with the ASX Listing Rules; and
 - (ii) investors and their professional advisers would reasonably require for the purpose of making an informed assessment of:
 - A. the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - B. the rights and liabilities attaching to fully paid ordinary shares.
