ISSUE OF SECURITIES - CLEANSING NOTICE

Belararox Limited (“**BRX**” or “**the Company**”) advises that on 30 May 2024, it has issued 14,996,754 BRXOA options (exercisable at \$0.66 on or before 13 July 2026) (**Securities**) pursuant to shareholder approval received on 17 May 2024 (14,477,254 Securities), and issued to a consultant for services (519,500 Securities).

The Securities will rank equally with the existing BRXOA Options of the Company on issue.

Cleansing Notice

The Company issued the Securities on 30 May 2024 without disclosure to investors under Part 6D.2 of the *Corporations Act 2001* (Cth) (**Act**).
