ISSUE OF SECURITIES - CLEANSING NOTICE

Belararox Limited (“**BRX**” or “**the Company**”) advises that on 12 September 2024, it has issued 3,270,000 fully paid ordinary shares (**Shares**) pursuant to a project acquisition.

The Shares were issued at a deemed price of \$0.24 per Share. The Shares will rank equally with the existing Shares of the Company.

Cleansing Notice

The Company issued the Shares on 12 September 2024 without disclosure to investors under Part 6D.2 of the *Corporations Act 2001* (Cth) (**Act**).

For the purposes of section 708A(5)(e) of the Act, the Company notifies ASX that:

- (b) the Shares were issued without disclosure to investors under Part 6D.2 of the Act;

- (d) as at the date of this notice, there is no information that:
 - (i) has been excluded from a continuous disclosure notice given to ASX in accordance with the ASX Listing Rules; and
 - (ii) investors and their professional advisers would reasonably require for the purpose of making an informed assessment of:
 - A. the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - B. the rights and liabilities attaching to fully paid ordinary shares.
